



Requirements for Partner Government Agency Information in ACE & Methods for Submission

United States government agencies with a role in trade are working together to meet the White House Executive Order mandating Single Window completion by 2016. As part of this effort, CBP is transitioning core trade processing capabilities into the Automated Commercial Environment (ACE). In order to reach the 2016 deadline, CBP has established a timeline to facilitate mandatory filing of all electronic entries and their corresponding entry summaries in ACE.

Beginning November 1, 2015 a transition period will begin for electronic entry and entry summary filings in ACE. On February 28, 2016 ACE must be used for filing of all electronic entries and associated entry summaries. In addition, electronic FDA, NHTSA, APHIS (Lacey) data must be filed in ACE. Upon publication of a Final Rule (currently estimated by the end of July 2016), filers must use ACE to file data for AMS, APHIS Core, ATF, CDC, DCMA, DDTTC, DEA, E&C, EPA, FSIS, FWS, NMFS and TTB. Upon publication of the Final Rule, hybrid submissions, i.e., those that are a combination of electronically submitted information and paper forms, will no longer be accepted.

What follows is a list of agency forms or data elements required at time of entry or entry summary. Tables group the forms and data requirements by required filing date, associated agency, program/commodity, and includes related status for pilots, working groups, and technical documentation. The tables also identifies whether the forms will be submitted via the PGA Message Set or Document Image System (DIS).

To transmit required data, filers must adhere to the PGA Message set chapter of CBP and Trade Interface Requirements (CATAIR). Any agency specific requirements are captured through supplemental implementation guides (IGs). Documentation is located at: <http://www.cbp.gov/trade/ace/catair>

Additional forms or data not required at entry or entry summary will be supported by ACE as well, but will be announced through a separate announcement at a later date.

- PGA data that is filed electronically today via Electronic Data Interchange (EDI) at time of entry or entry summary must be filed via the PGA Message Set in ACE.

- PGA requirements at time of entry or entry summary that are met today via the submission of paper documents will require transmission by either the PGA Message Set or DIS.*

- Documents required by CBP for an ACE entry i.e., “docs required”, must be submitted via DIS. Documents required by CBP for an ACE entry summary, i.e., “docs required,” may be submitted either via DIS or the Portal.
