This pipeline contains an updated list of telephone numbers and contact information for the Area Port of Chicago. This pipeline supersedes any previous pipelines with the subject line "Port of Chicago Directory."

As of March 23, 2016, all ten Centers of Excellence and Expertise (Centers) expanded operations and assumed trade authority for post-release trade processes for their respective industry tariff lines. All ten Centers are now at full expansion.

For importers and/or filers filing entry summaries for importers who have applied to, been accepted and are managed by the Partnership Branch of one of the ten Centers, entry summaries will route to different team numbers. The table below identifies team numbers that are used by the respective Partnership Branch for each of the ten Centers. If an entry summary is assigned to one of the Center team numbers in the table below, it will be processed by the Partnership Branch staff that may be located at a physical location other than the Area Port of Chicago. These importers and their filers should be aware of the Partnership Branch Center staff assigned to handle each importer's post-release workload.
