Attached please find a new listing of Port of Chicago telephone numbers. This pipeline supersedes all previous issued notices. In addition, this pipeline provides the phone numbers for the new location at 9915 Bryn Mawr, in Rosemont, IL 60018.

The move to the Rosemont location will consolidate most of the staff at 610 S. Canal, Chicago, IL 60607 and all of the staff at 2571 Busse Road, Elk Grove Village, IL 60007. Please note that Fines Penalties and Forfeitures, and the ABI Specialists will remain at 610 S. Canal, Chicago, IL 60607 so the numbers listed for them have not changed.

There are two primary Entry Specialist Teams: the Entry Unit and the Reports Unit. The Entry Unit processes all entry summaries assigned to the Entry Branch, such as warehouse entries, TIB's, entry summary rejections, permanent exhibition entries, etc. The Reports Unit is responsible for error resolution, focusing on error listings, such as the Unpaid Report, the Late Report, Overdue Rejected Entries Report, and the Unresolved Entries (CF 3461) Report. The Reports Unit is responsible for cancellations, please refer to Pipeline number 06-01 Amended dated March 1, 2006, for specifics.

Each filer is assigned an entry specialist in the Entry Unit; questions pertaining to entry processing should be directed to the assigned entry specialist. An updated listing of filer/entry specialist assignments will be provided at a later date, as we are currently filling a vacant position. However, if you have a question as to filer assignment you may contact Heather Mitchell, Entry Specialist Supervisor of the Entry Unit, at her number listed in the directory below.

Please note, when phoning a commodity team at the Customhouse, the **commodity team number** should be used, not an individual import specialist's number. An individual import specialist's direct number should only be used when responding to a specific rejection, request for information, etc. All general inquiries should be made on the team number.
