The Port of Chicago is pleased to invite the Trade Community to an Open House on Thursday, October 8, 1998, from 9:00 a.m. to 4:00 p.m. at the Customhouse, 610 South Canal Street, Chicago, Illinois. All Customs offices in Chicago will be participating, including the Port of Chicago, Mid America CMC, Strategic Trade Center, Customs Laboratory and Regulatory Audit, as well as the U.S. Department of Agriculture, U.S. Fish and Wildlife Service, U.S. Food and Drug Administration and the U.S. Consumer Products Safety Commission.

The Open House exhibits/tours include commodity team and entry specialist team displays, x-ray van, laboratory tour, metal tensile tester demonstration, Customs web-site demonstration, canine demonstration and many others.

Mr. **Robert Trotter**, Assistant Commissioner, Field Operations, will help kick off the Open House at the opening ceremony at 10:00 a.m.

Additional events at the Open House include a presentation on new Customs initiatives by Supervisory Import Specialist **Richard Rudin**, and a seminar presented by **Joseph Palmer**, Director, Regulatory Audit, on the Importer Compliance Monitoring Program.

As our guest, each firm attending the Open House will receive a "Jump to the Head of the Line" card upon registration. Walk one block south to Harrison Street and one block east to Canal Street. The registration tent will be in front of the Customhouse. For **METRA** riders, the Customhouse is 2 blocks south of Union Station and 5 blocks south of Northwestern Station.
